

RESOLUTION – 2026-05

RESOLUTION ESTABLISHING THE COMPENSATION FOR SALARIED COUNTY OFFICERS FOR CALENDAR YEAR 2026

WHEREAS, MCL 45.421(1), specifically addresses the manner in which the annual salary of salaried county officers is determined. It states, *“The annual salary of each salaried county officer, which is by law fixed by the board before November 1 each year and shall not be diminished during the term of which the county officer has been elected or appointed, but may be increased by the board during the officer’s term of office.”*

WHEREAS, Attorney General Opinion # 6941 further clarifies, *“We agree with the circuit court that MCL 45.421(1); MSA 5.1101(1) empowers the county board of commissioners to increase salaries of county officers during their term of office without limitation as to the effective date of such increases. The statute neither requires only one raise per year nor sets a date on which the raises become effective.”*; and

NOW THEREFORE, BE IT RESOLVED, that the Menominee County Board of Commissioners fixes the annual salary of the salaried county officers as follows:

OFFICER	2025 SALARY	2026 SALARY
Clerk/Register of Deeds	\$75,000.00	\$77,062.50
Prosecuting Attorney	\$114,300.00	\$117,443.25
Sheriff	\$100,000.00	\$102,750.00
Treasurer	\$73,700.00	\$75,726.75

BE IT FURTHER RESOLVED, that the new salaries shall take effect on March 24, 2026.
