August 8th, 2007
Minutes

Members Present: Mark Aubert, Bill Kakuk, Viola Bleile, Tina Lesperance and Greg Furmanski

Meeting called to order by Chairman Mark Aubert at 6:04 PM.

A motion made by Greg Furmanski and seconded by Viola Bleile to accept the agenda. Motion carried.

A motion made by Bill Kakuk and seconded by Greg Furmanski to approve the minutes. Motion carried.

Public comment: Questions concerning the timeline of October for getting weeds cut at Kleinke Park. Asked committee if date of September 1st could be made to finish.

Complaints about shower at Kleinke Park. Too much sand in shower. No place to make payments for rent. Could box be put up so people could leave payments?

Signage for park entrances at Kleinke are hard to see. Can they be made more visible somehow? They have been placed in spot where public can not see from road.

Committee Business: Wages for Summer help that were **recommended where approved and forwarded to County board for approval**. Motion made by Viola Bleile and Seconded by Greg Furmanski. Motion carried 5-0.

Park Fee changes for 2008. Recommended changes as follows:

Camping Shakey Lakes:

Electric Campsites (50Amp where available) from 17.00 to 18.00 per night.
Electric Campsites (20 Amp where available) from 15.00 to 16.00 per night
Non-electric campsites from 12.00 to 13.00 per night.

Camping Kleinke:

Electric Campsites (50 Amp electric, where available) from 17.00 to 18.00 per night
Non-Electric campsites from 12.00 to 13.00 per night.

Kleinke/Shakey Lakes Park Lease Site Rates:

Seasonal Rates (6 months) for Electric Sites from 1000.00 to 1050.00

Seasonal Rates (6 months) for Non-Electrical from 750.00 to 800.00
Seasonal Rates (5 months) for Electrical Sites from 900.00 to 950.00
Seasonal Rates (5 months) for Non-Electrical from 650.00 to 700.00

Kleinke Park Lease Site Rates:

Seasonal Rates (4 months) for Electrical Sites from 775.00 to 800.00
Seasonal Rates (3 months) for Electrical Sites from 675.00 to 700.00
Seasonal Rates (2 months) for Electrical Sites from 500.00 to 525.00
Seasonal Rates (1 month) for Electrical Sites from 275.00 to 300.00

Motion made by Bill Kakuk and seconded by Greg Furmanski to **send recommended changes to County board for approval.** Motion carried 5-0

Motion made by Mark Aubert and seconded by Tina Lesperance to table the issue because Steve Wery was absent due to illness. Motion carried by 5-0.

Shakey Lakes Concession Stand issue: The concession stand has not been opened at all this camping season. The lease payment has not been received also. Discussion followed as to what to do. Conclusion was to move to all Vending machines and change design of shower building to include a place for coin operated laundry equipment. Eliminate the concession stand. Motion made by Bill Kakuk and seconded by Viola Bleile to discuss move on this idea and discuss with Steve Wery. Motion passed by 5-0.

Motion made by Tina Lesperance and seconded by Viola Bleile to Notify Dan Hass by board to eliminate lease and concession stand. Motion carried 5-0.

Motion made to approve 07/08 Budget review and 3rd quarter Revenue/Expense report. Motion carried 5-0.

Park Superintendant updates: Steve Wery not present at meeting due to illness. Mark Aubert reported that Horse Arena improvements are coming along. Approximately 50 stumps have been removed. Seeding taking place presently and planting of trees along road planned to be done in the near future.

Public Comment: Parks People at Shakey Lakes and Kleinke Parks doing great job. Fishing Museum volunteers wanted to know if gravel could be applied to entrance road up to museum gate.

Motion made by Greg Furmanski and seconded by Bill Kakuk to adjourn the meeting at 6:42 PM. Motion carried 5-0.
