PLEASE TAKE NOTICE that any qualified elector who is not already registered, may register to vote at the office of the appropriate City/Township Clerk; The Office of the appropriate County Clerk; a Secretary of State branch office or other designated state agency. You may also register to vote online. Online Voter Registration can be found at www.michigan.gov/vote. Voters who are already registered can verify their voter registration information at the same website.

The last day to register in any manner other than in-person with the local Clerk is **Monday, October 19, 2020.**

After Monday, October 19, 2020, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the following:
